To the extent the work and the presentation incorporate text passages, figures, data or other material from other authors, the abstract submitter confirms that all necessary permissions have been obtained to grant the license above.

Furthermore, the abstract submitter grants the organizers permission to use, distribute, publish, record, broadcast, reproduce and archive their presentation and comments at the conference in any format or medium.

Finally, the abstract submitter confirms that they have the power and authority to make and execute this form. For jointly authored works the signing author signs as authorized agent for the others. In the context of abstract submissions, the organizers may process and use the contact details provided for co-authors solely for submission-related notifications and organizational communication.

The event may provide a conference app that participants can download and use.
